

Suquamish Clearwater Casino Resort

CONSENT UPON ENTRY

Entry into the casino and or premises by any person, shall constitute consent to restraint and detention by authorized casino employees or agents having reasonable cause to believe one has violated any applicable federal, state, and or tribal law, ordinance, or rule governing the facility and gaming for the purpose of delivery of said person to the appropriate law enforcement jurisdiction for criminal prosecution. Packages, bags, and purses may be subject to search.

ID REQUIREMENTS

The following forms of identification are valid to be used for player's club enrollment, age verification, jackpot payouts, promotion prizes and Title 31 requirements, with exceptions as noted:

Any **current identification card or driver's license** issued by a domestic or foreign **government agency, Military ID, Passport, Tribal ID and U.S. Citizenship and Immigration Services (USCIS) Green Card.**

Exceptions: For liquor sales – age verification – must be issued by the governing authority of a federally recognized Indian tribe located in Washington State. Green cards are **not** valid for age verification for liquor, beer or tobacco purchases per Washington State Liquor Control Board policy.

It is property's policy to check all guests ID for liquor sales that look 40 years of age or younger.

State issued ID that is vertical will not be accepted for liquor sales

IF YOU ARE UNDER 21, YOU MUST CHECK IN AT THE SECURITY PODIUM OR WITH A SECURITY OFFICER.

NO ID, NO ENTRY*

***ID must be legible. Ripped, bent expired or damaged ID is unacceptable.**

All minors, if on the gaming floor, must continuously walk until they reach one of the following destinations: restaurant, restroom, event center/hotel, or exit, EVEN when accompanied by an adult.

Children under the age of 12 must be accompanied by an adult at **ALL TIMES.**

GENERAL RULES

Marijuana, pipe smoking, cigars and chewing tobacco are prohibited.

Side betting between players and between players and the casino are prohibited.

Cell phones, headsets, and other electronic devices are prohibited at the gaming tables.

No outside food, drinks, or outside drink containers.

Proper attire is required. You may be asked to cover up or change out of inappropriate clothing or remove items that cover your face or head including sunglasses, hats, and sweatshirt hoods.

Weapons are not allowed. It is unlawful for a person to enter this establishment while he or she knowingly is in possession or knowingly has under his or her control, a weapon. This includes those persons that possess a concealed weapons permit. Exception: Law enforcement and personnel or employees so designated by the Tribal Gaming Commission.

Lost or Stolen Property: All found items, including tickets must be turned in to Security. Failure to do so will result in contacting law enforcement. SCCR and its affiliates will not look for lost or stolen tickets for guests. It is the guest's responsibility to ensure they receive their ticket before leaving their machine.

Service Animals Welcome: Animals providing comfort, companionship or emotional support are not allowed and do not qualify as service animals.
